REGULAR BOARD OF EDUCATION MEETING SLINGER SCHOOL DISTRICT SLINGER, WISCONSIN May 20, 2024 High School IMC

Routine Business:

The meeting was called to order by Vice-President Ken Strupp at 7:00 PM in the High School IMC.

Members answering roll were: Roman Weninger (on-line), Ken Strupp, Gary Feltz, Cherie Rhodes, Jody Strupp, Brenda Lighthizer, and Heidi Lofy. Curler affirmed the public notice.

After review and discussion of the minutes presented, motion by Feltz, seconded by Rhodes, to approve the four (4) sets of minutes as presented. Motion carried.

Hug reviewed the highlights of the financial report and asked if there were any questions regarding the information presented. After discussion, there was a motion by J Strupp, seconded by Lighthizer, to dispense with the reading of the financial statement and approve as presented. Motion carried.

After discussion and clarifications of the voucher report, there was a motion by Feltz, seconded by Rhodes, to approve payroll check numbers (none-all ACH this month) and payroll direct deposit numbers 901078055-901078796 totaling \$1,176,977.10 and A/P check numbers 143184 -143397, A/P ACH numbers 232401401-232401544, and wire transfers totaling \$1,732,299.99 (to include any voided transactions as presented). Motion carried.

New Business:

Public Comment and Question session was granted. K Strupp reminded the audience of the Board's guidelines for this portion of the meeting.

Curler presented an administrative recommendation to accept a letter of resignation from Slinger High School business ed teacher Cameron Carey beginning with the 2024-25 school year. The Board wishes to thank him for his service to the District. Motion by Lighthizer, seconded by Feltz, to accept the letter of resignation as presented. Motion carried.

Annual election of Board Officers was held and all Board Officer assignments will remain the same. Roman Weninger as Board President, Ken Strupp as Board Vice President, Jody Strupp as Board Treasurer, and Cherie Rhodes as Board Clerk. Motion by Feltz, seconded by Lofy, to keep the Board Officer assignments as is. Motion carried.

Annual assignment of CESA 6 board representative; Feltz agreed to keep his position as Slinger's representative. Motion by Rhodes, seconded by J Strupp to approve the assignment. Motion carried.

Curler presented an administrative recommendation to approve the Pupil Nondiscrimination report for 2024. This is an every 5-year requirement from the Department of Public Instruction. Many individuals are involved in preparing this report to include the counseling staff. They are analyzing the district's course options and bringing in all populations for inclusion. Curler highlighted a few more topics and after discussion, a motion by J Strupp, seconded by Lighthizer, to approve the report as presented. Motion carried.

Brooks presented a report from the most recent Curriculum Committee meeting regarding the mental health programs being proposed to the middle and high school curriculum for the 2024-25 school year. Brooks presented an administrative recommendation to accept the middle school Character Strong program, the high school Sources of Strength program, and the addition of suicide prevention classes to the 7th and 8th grade Health curriculum as presented. After additional discussion and showing the timeline of how these programs were selected and presented, motion by Feltz, seconded by J Strupp, to approve the Character Strong program for the middle school beginning with the 2024-25 school year. Motion carried. Motion by J Strupp, seconded by Lighthizer, to approve the Sources of Strength program for the high school beginning with the 2024-25 school year. Motion carried. Motion by Rhodes, seconded by Lofy, to approve the suicide prevention classes to be added to the 7th & 8th grade Health curriculum beginning with the 2024-25 school year. Motion carried.

Curler presented an administrative recommendation to approve the proposal brought to the members during a previous meeting regarding paying an extra stipend to coaches/district staff for driving school busses to and from extracurricular events. Motion by Feltz, seconded by Lofy, to approve the recommendation as presented. Motion carried.

Curler presented an administrative recommendation to approve the proposal brought to the members during a previous meeting regarding the harvesting of trees from 16 acres of district owned property located south of Hwy 60 and east of Hwy 41. The revenue from the harvest will total approximately \$16,000 and will take approximately six weeks to complete. 60% of the trees will remain. Motion by J Strupp, seconded by Lighthizer, to approve the recommendation as presented. Motion carried.
